**Brief Summary and Statement of Need:**

Funds deferred maintenance at 35 state-owned buildings with a replacement value of \$209.1 million, along with selected leased facilities, including urgent immediate repair, renovation and equipment needs. Delay in funding will cause additional deterioration of the Department's facilities. Urgent repairs and deferred maintenance cannot be delayed continually without adversely affecting the State's investment in its facilities.

**Project Description/Justification:**

This project funds deferred maintenance at Department of Health and Social Services (DHSS) facilities statewide, including immediate and critical renewal, repair, replacement and equipment needs. DHSS is responsible for 35 state-owned facilities with an estimated replacement value of \$209.1 million. The FY01 general funds requested amount to less than one-half of a percent of that value. The Department is also responsible for a limited amount of special repairs and upgrades not covered by lease agreements at leased sites (over 80). The Department's facilities have ongoing as well as deferred maintenance and equipment needs resulting from heavy usage by staff and a variety of client groups. Funds will address these needs and maintain the state's investment in the Department's facilities.

Funds requested for FY01 will only cover highest priority immediate needs. The funding shown for the six year period was developed after a calculation of the amounts required for current repair, renewal and replacement needs for buildings comparable to those maintained by the Department. Additional funds were then added to address the current backlog of deferred maintenance projects. Delaying the minimal level of funds needed for urgent deferred maintenance will have a destructive impact on the State's investment in infrastructure and will lead to greater costs in the future.

**I. Ongoing Repair, Renewal and Replacement Needs**

The funding level to keep up with repair, renewal and replacement needs (above and beyond ordinary day to day maintenance) can be estimated by using standard formulas that are based on the cost of replacing a building. One formula assumes a constant proportion of annual maintenance costs over the life cycle and is derived as a percentage (1.5%) of building replacement costs; the other (the widely used Sherman-Dergis method) attributes greater costs to older buildings (= Replacement Cost x 0.75 x (Age of Building/1275)). The following estimate of needs is based on the average of results from both formulas. The Alaska Psychiatric Hospital has not been included in these formula computations, because the Department hopes to replace that facility. Interim stopgap needs for that facility are included in the list of representative projects shown in the table at the end of this description. Total annual repair, renewal, replacement and equipment needs, without considering deferred maintenance are thus estimated as follows:

- FY01: \$1,676.0
- FY02: \$2,176.2
- FY03: \$2,541.5
- FY04: \$2,797.8
- FY05: \$2,881.7
- FY06: \$2,968.2

**2. Deferred Maintenance**

All facilities require regular maintenance, renewal, and repair to remain in good operational condition, and the state needs to protect its investment in capital facilities. Unfortunately, the Department has not had the financial resources to adequately maintain, repair, or renovate its facilities and the deferred maintenance backlog has continued to grow over the years. Eventually buildings deteriorate to such an extent that they must be replaced, usually at a cost greater than would have been required to pay for adequate maintenance, repair and renovation.

The Department has recently completed a comprehensive and thorough series of building condition audits for all of its state-owned facilities. Those audits identified \$7.3 million in urgent deferred maintenance, renewal, and replacement projects, for which the funds requested for this project could be used (excluding projects requested elsewhere). Many of the projects represent immediate needs and are critical to maintaining the integrity of specific facilities. (See project list below.) While based on a thorough and professional analysis of the condition of the Department's buildings, this list is subject to change as projects become more defined and as other needs become evident. Actual allocation of funds to particular projects will depend on a determination of current priority and emergency needs at the time that funds become available.
