Project Description/Justification:

The capital funds may be needed for demolition of the old building. A final decision has yet to be made concerning which building option to pursue.

Performance Measure:
 Completion of API 2000 Project.

The \$1,000.0 in MHTAAR funds for the API 2000 capital project is needed in FY01 because this funding is an integral part of phased funding plan that incorporates a combination of State GF/MH, State Medicaid, Federal Medicaid and SAMHSA, and MHTAAR funds in order to accomplish the replacement and demolition of the existing, aged API facility, and a concomitant growth in private, non-profit, community-based services to accommodate the reduced bed capacity of the API replacement hospital. This proposed capital appropriation in FY01 reflects the achievement of a complex agreement among a number of state agencies and consumer/advocacy groups for a five-year, phased project that will, if fully implemented, see a substantially increased private sector role in the provision of mental health services while overseeing public sector cost savings from a downsized state psychiatric hospital.
