**Project Description/Justification:**

The purpose of the program is to provide funds for the development of senior citizen housing.

The projected outcomes are:

- Purchase of building sites,
- Site preparation,
- Purchase building materials,
- Construction,
- Rehabilitation, including accessibility modifications,
- Preparation of plans and specifications,
- Project feasibility studies,
- Appraisals, and
- Other pre-development activities.

These funds are used to support the development of housing for the fastest growing segment of the Alaskan population, persons 60 years of age and older. A statewide needs assessment done in 1996 showed that there was a demand for an additional 1,000 units of senior housing. This number is projected to increase by an additional 3,300 by the year 2010.

This program targets the housing needs of both low-income and middle-income seniors, as well as, assisting home-

owners improve accessibility in their homes insuring safety and the ability to stay in their residence.

This request will be applied to the FY2001 application cycle already completed for the SCHDF program. Awards are made on a competitive basis contingent on legislative approval. Program funds are used only to fund the development GAP, i.e., the amount necessary to make the project financially feasible - or the difference between all other funding sources which can be expected to be contributed (including loan funds) and the cost to develop the project.

Any remaining unused funds will be made available under the FY 2002 funding cycle. Requested funds are to be used to support senior housing with gap funds for acquisition, rehabilitation, accessibility modifications, and/or new construction of senior housing.
