Compliance with the Clean Water, Clean Air and Hazardous Waste Management Related Acts is required by Federal Law. Contamination and waste from historical activities, airport and tenant operations must be remediated and disposed of properly, in addition to standard environmental compliance actions and operations of the facility.
