**Brief Summary and Statement of Need:**

Funding will be used to begin to fix some of the facility maintenance problems that are of critical concern now in the buildings comprising the Non Public Building Fund facilities group managed by DOA. These buildings are: the State Museum and Annex in Juneau; the Diamond Courthouse in Juneau; the Governor's House in Juneau; the 3rd Floor of the Capitol Building; the Juneau Subport Building; and, the Archives and Records Center in Juneau.

Of immediate concern are leaking roofs, curtain walls that are no longer water resistant, bursting domestic water supply lines, inoperable HVAC systems, foundation failures, hazardous material abatement, and unsafe, inefficient boiler and heating systems.

**Project Name**      Non Public Building Fund Facilities Maintenance Projects

**Problem:**      This CIP funding request will begin to fix some of the facility maintenance issues that are of critical concern now in the buildings comprising the Non Public Building Fund facilities managed by the Department. These buildings are: the State Museum and Annex in Juneau; the Diamond Courthouse in Juneau; the Governor's House in Juneau; the 3rd Floor of the Capitol Building; the Juneau Subport Building; and, the Archives and Records Center in Juneau.

Leaking roofs, curtain walls that are no longer water resistant, bursting domestic water supply lines, inoperable HVAC systems, foundation failures, hazardous material abatement, and boiler and heating systems which are inefficient and unsafe are all issues of immediate concern.

**Solution:**      Funding for capital projects to replace building components which include, but are not limited to: leaking roofs, failing soffits, curtain walls and window systems; removal and disposal of hazardous materials; removal and replacement of failing domestic water pipes; and foundation repairs.
