**Project Description/Justification:**

This request includes numerous small remodeling projects at many courts around the state. In general they fall into three categories: 1) remodeling the judicial bench and in-court stations in the courtrooms to accommodate the technology that improves timeliness and accuracy of court proceedings 2) installing lighting to improve the safety of employees and public accessing our facilities, and 3) working on customer service counters to improve access. The trial courts in Anchorage need a multi-litigant courtroom to handle civil cases and a grand jury hearing room in the Boney Courthouse.

The Kotzebue courthouse, constructed in 1971, is the most substandard superior court facility in the state. The space is poorly laid out due to piecemeal expansions and remodel projects which addressed urgent needs in the past. It has many functional problems, including antiquated heating, ventilation, and electrical wiring systems. The building also needs new interior finishes, and 1600 square feet to provide an adequate superior courtroom, jury assembly and judicial offices. Expansion and improvement at the existing facility will be difficult because there is not adequate unused land adjacent to the courthouse, and temporary space to house the court during construction has not been found. Department of Military and Veterans Affairs (DMVA) has indicated a willingness to enter a long-term lease with the court system. This request covers the funds needed for construction and remodel of the DMVA armory space.

The court system is installing computers, digital recording systems and other equipment to improve efficiency of proceedings in the courtroom and to improve the quality of the recorded transcripts. Many courtrooms constructed prior to 1985 do not provide adequate space in the in-court station to accommodate the equipment being installed. Also, the judge's bench often is not designed to provide good ergonomics for a person seated in a restricted area for several hours

of the work day.

The parking garage in Anchorage does not have adequate lighting to ensure safety during hours of darkness. There are also buildings that do not have adequate exterior lighting to ensure safety for court system staff. This request includes funding to install additional lighting.
