### **Component Mission**

To foster, support and promote the ethic of service and volunteerism and to engage Alaskans of all ages and backgrounds in tangible, results-oriented community projects.

### **Component Services Provided**

The Alaska State Community Service Commission is required to:

- Develop a Unified Plan of Service for Alaska which details our involvement in programs funded by the Corporation for National Service in conjunction with in-state support.
- Apply for Administrative and Program Development and Training funding supporting the Commission and AmeriCorps Programs in the state.
- Promote participation in AmeriCorps by non-profit agencies that develop programs meeting the requirements of CNS funding and addressing community needs in the areas of education, public safety, human and environment needs.
- Provide technical assistance to successful sub-grantees.
- Provide the structure for distribution of funds including the accounting and financial monitoring of programs.
- Provide the programmatic monitoring of sub-grantees and assure compliance with state and federal regulations.
- Generally, seek opportunities to partner with other organizations to increase and enhance volunteerism and community service in Alaska.

### **Component Goals and Strategies**

- To increase community service in Alaska by taking advantage of funding opportunities through the Corporation for National Service.
- To maintain or increase the level of Alaska participation in the Education Award Only Program component.
- To increase the awareness of ASCSC programs in the state.
- To promote participation in National Service Days.
- To host the second annual statewide conference on community service and volunteerism.
- To develop a plan for growth and focus of the programs of the Alaska State Community Service Commission.
- To resolve any issues and findings from the Inspector General's Audit.
- To further our partnerships with other agencies and organizations that are also working to address community needs through service including faith-based organizations in Alaska.
- To take a greater role in coordination and support of service and volunteerism in Alaska.

### **Key Component Issues for FY2003 – 2004**

Collaborating with non-profits, business, and other organizations that also are working to promote community involvement to achieve a greater ethic of service in Alaska. To support programs which seek to instill this ethic of service, especially in young people.

### **Major Component Accomplishments in 2002**

- The ASCSC and community completed the Standards Review done through the Corporation for National Service.
- We successfully completed our second Learn and Serve year of funding with programs in three school districts.
- The Commission sponsored the first Statewide Conference on Service and Volunteerism.

- Our second annual report was completed and distributed in February.
- The Commission is now staffed by the Executive Director, an Assistant and a secretary. The level of staffing is now adequate to handle the growth in Commission activity and all staff have been in the positions more than one year.
- A youth member has been added to the Commission and has been trained in the role of a youth commissioner.
- Alaska has completed the first year of operation with our first two America's Promise Fellow positions.
- We successfully completed our second year in the Digital Divide Program.
- The Commissions has made more training opportunities available to program staff, commission members, and commission staff than ever before.
- The Commission and Program staff has become more proficient and reliant on our Web-Based Reporting System for monitoring programs.
- A comprehensive Policy and Procedure Manual has been developed for reference and to assure a smooth transition with the upcoming change of administrations.
- The Commission has undergone an audit by the Inspector General's office of CNCS with minimal findings that are being addressed and resolved.
- The Commission's office has relocated to the Professional Development section of the Department of Education and Early Development.

Proposed Changes in Levels of Service for FY2004**

**Annualize FY2003 COLA Increase for General Government Bargaining Units (\$.9)**

In FY2003 COLA increases were not in effect for the entire year for the General Government, Confidential and Supervisory bargaining units. This request adds funding to pay the COLA for these bargaining units for the full year in FY2004.

**\$75 per Month Health Insurance for Non-covered Staff (\$2.8)**

The employer contribution to health insurance for non-covered staff will increase by \$75.00 from \$630.00 per month to \$705.00 per month.

**Transfer Alaska State Community Service Commission to DCED**

Transfer the Alaska State Community Service Commission to the Department of Community & Economic Development to achieve efficiencies through the consolidation of program service delivery within the appropriate agency.
