**Section 402 - STATE AND COMMUNITY HIGHWAY SAFETY GRANT PROGRAMS**

To support a state highway safety program designed to reduce traffic crashes and resulting deaths, injuries, and property damage. Funding is used to identify highway safety problems, set goals and performance measures for highway safety improvements, provide start-up money for new programs, give direction and support to existing safety programs, and fund analyses to determine progress in improvement safety.

### Section 405(a) - OCCUPANT PROTECTION INCENTIVE GRANTS

### Section 157 - SAFETY INCENTIVE GRANTS FOR USE OF SEAT BELTS

### Section 157 - SAFETY INNOVATIVE GRANTS FOR USE OF SEAT BELTS

To provide funding to increase police enforcement of seat belt and child restraint laws and public education efforts on the use of seat belts and child restraints.

### Section 405b (aka 2003b) - CHILD PASSENGER SAFETY INCENTIVE GRANTS

To encourage States to adopt and implement effective programs to reduce highway deaths and injuries resulting from children riding unrestrained or improperly restrained in motor vehicles.
