This request is to convert the Palmer Pioneers' Home from its current use to a State Veterans Home (SVH). The 82-bed facility would become a 78-bed SVH domiciliary care facility with 62 private and 8 semiprivate rooms. Occupancy of the proposed facility is projected to be 90 percent, similar to that of other Pioneers' Homes in the state.

This is the first year of the project.

**Project Description/Justification:**

Based on an appropriation by the Legislative Audit and Budget Committee, a consultant was commissioned to complete the report: *Alaska Veterans Home Feasibility Study*. That report was very useful, and based on the findings and recommendations of the report, Governor Murkowski has decided to proceed with the option: Convert the Palmer Pioneers' Home into a State Veterans Home.

In August of 2003, the U. S. Veterans Administration (V.A.) visited the Palmer Pioneers' Home and outlined the construction requirements for conversion to a Veteran's Home. The V.A. construction requirements are quite a bit different than what was outlined in the report, *Alaska Veterans Home Feasibility Study*. It is for that reason that the cost presented here is different than the cost presented in that report.

A preliminary estimate for the entire conversion construction cost is approximately \$3.5 million since converting the Palmer Home to a Veterans Home will involve a great deal of physical infrastructure upgrades as required by the V.A.. They require that a Veteran's Home be guaranteed as much as possible to be physically sound for the next 20 years. To achieve this, it will be necessary to upgrade the heating systems, electrical systems, and to make seismic safety and energy conservation improvements, as well as meeting the ADA accessibility regulations, fire, mechanical, and other appropriate codes. A better-cost estimate will be available in January/February 2004, when the initial architectural and engineering work is complete.

**State Veterans' Home Conversion - Palmer**

The August meetings with the V.A. were extremely promising and hopeful. According to our discussions with the V.A., the next step is for the State of Alaska to submit a formal grant application for funding of the Palmer Veterans Home Conversion by April 15, 2004. That process is underway.

The Palmer Pioneers' Home was constructed in 1970 to serve Alaska pioneers. It is approximately 70,000 square feet in size and has a replacement value of \$15.1 million. This request will fund conversion from its current use to use as a State Veterans Home (SVH). The 82-bed facility would become a 78-bed SVH domiciliary care facility with 62 private and 8 semiprivate rooms. Occupancy of the proposed facility is projected to be 90 percent, similar to that of other Pioneers' Homes in the state.

While licensed as a SVH domiciliary care facility, the home would be operated as an assisted living facility. The facility would operate like a Pioneers' Home and would meet the needs of veterans over several care levels. Some veterans who had already been admitted to nursing homes could potentially qualify for admission to the proposed facility if they meet the comprehensive care service level of need.

Primarily veterans would occupy the facility, with a number of beds occupied by non-veterans as allowed by federal regulations. Veterans would be placed in the facility through attrition (i.e. no current residents would be forced to move) in preparation for renovation. The current veteran population would remain. Once renovations are complete, veterans on the active waiting list for the Pioneers' Homes would be offered residence at the State Veterans Home. Veterans currently residing in other Pioneers' Homes would be transferred to the State Veterans Home only at their request. Future admissions would be primarily limited to veterans, based on their clinical care needs and bed availability.

Average attrition rates (through death) at the Palmer Pioneers' Home indicate that it would take approximately three years to convert all the designated beds from non-veterans to veterans. This does not take into account transfers from other Pioneers' Homes or any recruitment efforts to fill these beds with veterans.

Department's Mission: *To promote and protect the health and well being of Alaskans.* This project will provide a place for veterans to get the care and housing they require. Converting the Palmer Pioneers' Home to a State Veteran's Home will contribute to the Department's mission by providing this needed care and housing.
