**Project Description/Justification:**

This project will provide gap funding for individuals in the Home Choice Voucher Homeownership program being administered by the Alaska Housing Finance Corporation (AHFC). Eligible participants are families where either the head of household or spouse is a person with a permanent physical, mental or developmental disability, have completed a one year rental under the HCV program, are in good standing with their landlord, have completed an AHFC pre-approved homeownership class and are first time homebuyers. Participants must come up with a three percent down payment of which one percent is from the family's personal resources.

These funds will assist those participants in the HCV Homeownership program that require gap funding to qualify for the down payment and related costs of home ownership.
