# **Component: Children's Trust Programs**

# **Contribution to Department's Mission**

The mission of the Children's Trust Programs is to provide funds for community-initiated programs to strengthen families and eliminate child abuse and neglect.

#### **Core Services**

The Alaska Children's Trust program generates funds and commits resources to community-initiated projects that strengthen families and prevent child abuse and neglect. The Children's Trust awards grants from the net income of the Trust Fund to community-initiated projects on a competitive basis, monitors the approved grant projects for compliance and effectiveness, and submits to the Governor a report describing the services provided and the annual level of income and expense. The Trust solicits contributions through fund-raising activities, gifts and bequests and applies for private and federal grants consistent with the purpose of the trust, to increase the value of the fund.

# **Key Component Challenges**

Educate the public of the purpose of the Children's Trust Program. The Alaska Children's Trust proposes to initiate a media campaign to promote an awareness of the Children's Trust Programs. A one-time federal grant from the US Department of Justice will fund this initiative in FY2005-2006.

The income from the Children's Trust Fund continues to be affected by fluctuations in financial markets. Fluctuations impact the funding available to support this program.

### Significant Changes in Results to be Delivered in FY2006

A half-time administrative support position was established in FY2005 to help manage administrative activities for the Children's Trust Programs. No other changes in results delivered.

#### **Major Component Accomplishments in 2004**

Development was concluded on new strategic plan to outline goals and activities in Alaska Children's Trust operations. The published plan and a revised directory were distributed to trustees.

Increased the trust fund principal due to fund raising and increased investment interest earnings. Trust assets reached a \$10 million milestone in FY04.

Approved written findings on projects including measured effectiveness of programs or projects.

Special merchandise--heirloom birth and marriage certificates, license plates, little bear's Alaska Reader books were sold to raise additional revenue for the Trust.
