Component: Catastrophic and Chronic Illness Assistance (AS 47.08)

Contribution to Department's Mission

Provides a limited package of health services to those individuals with chronic medical conditions who do not qualify for the Medicaid program.

Core Services

The CAMA program provides a limited package of health services to those individuals with chronic medical conditions who do not qualify for the Medicaid program. CAMA's limited benefits are only available to low-income persons with an immediate need for medical care who are unable to secure other private or public assistance.

During the FY04 budget process, the CAMA appropriation was cut from \$2 million to \$1.5 million and remains at that level through FY05. These funds provide services to Alaska's indigent for prescription drugs for the terminally ill, chemotherapy patients, and people with certain chronic conditions that without treatment would lead to disability or death. No additional funding is requested for FY06.

There are no significant changes in the results delivered by the CAMA program.

Major Component Accomplishments in 2004

The CAMA program provided payment for 1,521 individuals within the appropriated general fund amount in FY2004 through regulations that reduced services provided and aggressive management of claiming adjustments for payments made by CAMA for individuals who become Medicaid eligible.
