Component: Senior and Disabilities Services Administration

Contribution to Department's Mission

To provide oversight of the waiver and grant programs for Alaskan Seniors and Disabled individuals, and to provide administrative support to the program staff.

Core Services

This component provides centralized support services for four Medicaid Waivers and Senior Services and Community Developmental Disabilities Grants programs. Services include general administration, budget development and fiscal management, contract administration, service system planning, development of service and training initiatives, maintenance and upgrade of the automated information systems, and oversight of the senior services and developmental disabilities grantee programs. Direct services include quality assurance, Adult Protective Services, technical assistance, case management, and consultation, Nursing Home Facilities, Nursing Home Transitions and Personal Care Attendant through Medicaid Waivers and Grant programs. The Division works closely with the Alaskan Commission on Aging, the Governor's Council on Disabilities and Special Education, and the Alaska Mental Health Trust Authority to determine policy governing the planning and implementation of services and supports for people who experience developmental disabilities or Alzheimer's Disease and related dementias.

Key Component Challenges

- In FY2005 all administrative and support costs were consolidated into this component. This more accurately reflects the division's way of doing business.
- > The Division of Senior and Disabilities Services programs currently rely upon numerous duplicative, labor-intensive, and ineffective computer systems. With support from the Alaska Mental Health Trust Authority, the division is creating a functional, integrated data environment.
- In order to successfully integrate the two previously separate divisions, classification work is being done in order to develop consistency between the Developmental Disabilities and Senior Services staff.
- > Better define Quality Assurance activities through division and department level steering committees.

Significant Changes in Results to be Delivered in FY2006

Under Executive Order 108 the division continues to work at consolidating senior and developmental disabilities services in a seamless program that will better serve the citizens of the state.

If the transfer between the SDS Medicaid Services Component and the SDS Administration Component is approved, the recent mercurial growth of the Personal Care Attendant Program should be restrained.

Additional resources are being added to strengthen the Adult Protective Services program. Over 1,385 vulnerable adults

Major Component Accomplishments in 2004

- Nearly 3,000 individuals served by 52 grants to 35 organizations in 100 communities across the state.
- Have recruited and trained 127 volunteers for the Medicare outreach program throughout the state.
- Responded to 170 complaints about Medicaid Waiver provider service.
- Conducted orientations to more than 50 prospective assisted living home operators.
- Monitored and provided technical assistance to approximately 165 assisted living homes statewide.
- Continued the division's efforts in rural assisted living home development.
- Responded to 1,384 calls regarding the health and safety of the State's senior population.
- Contracted out the assessment for the Older Alaskans and Adults with Physical Disabilities Waivers in order to eliminate any potential conflict of interest that may have existed when the Care Coordinators were performing the function.
- Provided 32 rural outreach presentations through the Adult Protective Service program.
