#### **Component: Epidemiology**

#### **Contribution to Department's Mission**

The Department's mission is to promote and protect the health and well being of Alaskans. Epidemiology contributes to this mission by providing surveillance, epidemic response, investigation and control of acute and chronic diseases and injuries through defining causal factors, identifying and directing control measures and providing a basis for policy development, program planning and evaluation.

#### **Core Services**

Provide medical and epidemiological expertise required for disease control and epidemic response.

Maintain data systems to support surveillance, provide an accurate picture of the health status of Alaskans, and enable improved evaluation of program activities.

Assure adequacy of immunization outreach and access to vaccinations to insure that all Alaska children receive vaccinations to be in compliance with daycare and school immunization requirements.

Provide trained public health professional services for partner notification and contact identification, education, diagnosis, treatment, and tracking for tuberculosis, HIV, sexually transmitted disease (STD), and other infectious diseases that can be transmitted from person to person.

Maintain a system of direct disease reporting to the Section of Epidemiology from health care providers and laboratories.

Health promotion, screening and disease intervention activities to prevent and control chronic disease. Health promotion emphasis on tobacco prevention and control and promotion of physical activity and sound nutrition.

Obtain, analyze and disseminate information specific to the health status and health risks of women, children and families in Alaska for use in identifying and defining important health issues, so the service delivery system and resources can best be directed to address the problems and improve the overall health status of these populations.

Develop public health guidelines for consumption of subsistence foods.

Develop educational curriculum regarding Arctic environmental contaminants and continue measurements of exposure levels of Alaskans to contaminants.

### **Key Component Challenges**

Maintain medical and epidemiological expertise needed to accomplish disease control mission.

Continue to insure that all children are immunized on time.

Maintain direct observed therapy (DOT) for all persons who have infectious tuberculosis.

Ensure the legal authority to effectively and immediately respond to an urgent public health event, including involuntary isolation and quarantine, and acquisition and distribution of critical antimicrobial agents, vaccines and antidotes.

Establish and maintain a system of direct disease reporting to the Section of Epidemiology from laboratories.

Continued integration of Tobacco Prevention and Control and Health Promotion, Epidemiology programs, transferred into the Section of Epidemiology in FY 04 under the DHSS reorganization.

Create a new Section of Chronic Disease to integrate variety of prevention and control programs in order to better coordinate resources to address the increase in the impact of these diseases on Alaskans.

Insure that the funding and expertise is available for responses to bioterrorism, disease outbreaks, and control of emerging infectious diseases.

Support development of consensus guidelines for consumption of subsistence foods and commercial seafood.

Implement human biomonitoring for mercury, pesticides, and PCBs.

Support Alaska school districts as they work to implement the Youth Risk Behavior Survey (YRBS) under new constraints.

Insure tobacco evaluation information is used to apply funding to most effective prevention and control efforts.

Increase cooperative activities with sections in Division of Public Health, with other divisions within the Department of Health and Social Services, and with other agencies with health missions in Alaska.

#### Significant Changes in Results to be Delivered in FY2006

Expansion of human biomonitoring to include future biomonitoring of pesticides and PCBs.

#### Major Component Accomplishments in 2004

The Alaska Cancer Registry received the gold certification for high quality Year 2001 data from the North American Association of Central Cancer Registries. This is the fourth consecutive year the Registry has achieved this level of certification.

The Comprehensive Cancer Control Program has completed seven months of workgroup meetings with the Cancer Partnership. Four workgroups each addressed the issues and gaps, and then developed goals, objectives, and strategies in the areas of prevention, early detection, treatment/survivorship/palliation, and surveillance. The full Cancer Partnership met on October 13th to prioritize the strategies as the most feasible and having the most impact. All of these efforts will result in an update of the 1994 Alaska Cancer Control Plan.

The Vaccinate Alaska Coalition, a community-based program coordinated for the Alaska Immunization Program, received an Excellence in Immunization award from the National Partnership for Immunizations for the "I Did It By TWO!" campaign. This campaign integrates the important message of childhood immunizations with the Iditarod race, which commemorates sending diphtheria serum to Nome by dog sled during a deadly diphtheria outbreak. Children pass immunization "checkpoints" in order to cross the finish line, and are declared winners in the "Race to Vaccinate," just as mushers pass checkpoints in the actual race.

The HIV/STD Program has greatly increased efforts to focus disease intervention through community coalitions around the State. As a result of these local partnerships, gonorrhea declined 11% and chlamydia increased only 3% from 2002 to 2003. This is the smallest increase since 1999. In addition, one-third of the 33 newly diagnosed HIV cases were found through partner notification activities conducted or coordinated by the HIV/STD Program staff.

The Maternal Child Health Epidemiology Unit produced the first "Alaska Maternal and Child Health Data Book." This resource brings together information about the health status of Alaska mothers, infants, children and families based on statewide surveillance systems, surveys, vital records, and program services. The book is an excellent reference for information on population characteristics, reproductive health, prenatal health, birth outcomes, infant health, child and adolescent health, as well as women's and family health.

Expanded electronic reporting of laboratory test results for infectious diseases reportable to the Department of Health and Social Services (7 AAC 27.010) to include six hospitals in Alaska: Alaska Native Medical Center, Alaska Regional Hospital, Providence Medical Center, Fairbanks Memorial Hospital, Bartlett Hospital, and Ketchikan Hospital.

Tuberculosis (TB) Control Program worked with local public health nurses to screen several villages for tuberculosis. No village outbreaks of tuberculosis were identified in FY2004. The incidence of TB in Alaska in FY2003 was 8.8/100,000.

The Public Health Preparedness program introduced the first draft of the Alaska Strategic National Stockpile Plan at a statewide meeting. This plan directs when and how the State will request SNS asets from the CDC in the event of a public health emergency. The plan outlines how the assets will be distributed to every community throughout the State.

Successfully responded to Norovirus outbreaks among tourists and along the Iditarod Trail.

Developed a draft pandemic influenza plan for Alaska.

"Tobacco in the Great Land" was published, providing an extensive and comprehensive review of the tobacco problem in Alaska. These data are used to monitor tobacco-related behaviors, attitudes, and health outcomes. "Tobacco in the Great Land" serves as a benchmark for the tobacco prevention and control activities in Alaska.
