Project Description/Justification:

Repair, replace, upgrade ongoing maintenance, code and compliance projects for terminal buildings, and Airport facilities, systems, utilities, equipment, furnishings, floor and wall coverings, lighting and signage. This funding also assists with tenant relocations, terminal system and equipment evaluations, building maintenance and management programs, facility drawings and as-built drawings.

Projects include, but are not limited to

North Terminal Medium Voltage. The NTMV project will upgrade the 12.47 kva medium voltage electrical distribution system serving the North Terminal building. This will improve the reliability of standby generation in the building.

North Terminal Renovations. NTR projects will rehabilitate the north terminal ticket counters, repaint the interior and exterior of the building, replace wall coverings and renovate part of the Federal Inspection Service area.

Terminal Renovations and Upgrades. TR&U projects are for routing replacement and rehabilitation cycle construction for terminal building systems and components such as floor coverings, overhead doors, and HVAC system components. Terminal renovation construction that responds to changing facility needs and requirements and to ADA compliance deficiencies are also included.

Terminal Telecommunications Upgrades. TTU projects will upgrade voice telecommunications capability within the terminals by providing an integrated Voice over IP telephone switching capability.

Fire Alarm/PWDS/HVAC Controls Upgrade. The FACU project will modernize the fire alarm, Premise Wiring Distribution System and HVAC controls.
