Project Description/Justification:

Delay in the established replacement program can result in higher operating costs including increased risk of equipment failure and expensive repairs that are not recoverable in the remaining equipment life. The replacement program also contributes to the safety of the operators in providing the latest technological advances in the industry. The economic life of equipment is constantly monitored by State Equipment Fleet staff to obtain the lowest life-cycle cost possible.

Based on current projections, replacement payments to the Highway Equipment Working Capital Fund (HEWCF) by user agencies will fund this request within 2%. The remaining 2% will be made up from the sale of used equipment, projected to be \$900,000, as well as excess equipment no longer needed. Failure to replace equipment at the appropriate time results in higher operating and life-cycle costs. These higher costs are directly reflected in the operating costs of user agencies.

SEF replacement costs have exceeded the allocated replacement credits on equipment purchased in recent years. Central and Southeast Regions have unmet needs in replacing 6 vehicles in Soldotna and 7 vehicles in Juneau, Haines, Wrangell and Klawock. This equipment includes paint trucks, loaders, snow blowers, graders and dumb trucks. All are essential to the on-going maintenance of our road and airport systems.
