### Contribution to Department's Mission

The Lease Monitoring and Engineering Integrity Coordinator's Office contributes to this mission by improving both the development and conservation of resources through coordination of oil and gas permitting and oversight activities among all state and federal agencies with oil and gas related authority and responsibility.

### Core Services

- A. Review the quality assurance programs of unit/lease operators; prioritize areas of risk for corrective attention; identify gaps or weaknesses in the programs; exercise oversight of quality assurance actions and activities.
- B. Coordinate permitting actions and oversight activities between state and federal agencies with oil and gas related responsibility.
- C. Ensure there are no regulatory gaps or duplicative efforts in the regulation and oversight of oil and gas related infrastructure and activity.

### Major Component Accomplishments in 2006

The LMEICO was initiated by AO 229 on October 6, 2006.

Tasks to be accomplished during FY07 include:

1. hiring of core staff;
2. perform a regulatory gap analysis to ensure oversight of all oil and gas infrastructure and activities on state leases while avoiding duplication of effort;
3. establish permit coordination processes;
4. perform a risk assessment of the quality assurance program for the Prudhoe Bay Unit.
