# **Key RDU Challenges**

During fiscal year 2006, over 3,000 Alaskans contacted the ASCHR to inquire about their rights and responsibilities under Alaska's Human Rights Law. Given current resources new cases must remain on hold at any given time, awaiting assignment to an investigator.

### Significant Changes in Results to be Delivered in FY2008

The ASCHR will continue to evaluate new ways to further streamline case processing. With the restoration of 2 investigative staff this fiscal year the ASCHR will begin to reduce the delays in investigating complaints.

### Major RDU Accomplishments in 2006

The ASCHR continued to provide Alaska businesses and complainants the opportunity for voluntary mediation. The

- mediation program closed 33% more cases this past year. The U.S. Equal Employment Opportunity Commission chose ASCHR as one of only a few Fair Employment Practices Agencies in the country to provide its agency with mediation services.
- The ASCHR continued to review and streamline its procedures to more efficiently process complaints.
