# **Component: Assistive Technology**

#### **Contribution to Department's Mission**

This component contributes to the department's mission by providing a comprehensive statewide program of technology related assistance for individuals with disabilities.

## **Core Services**

This component provides for a system to assist persons with disabilities of all ages to live more independently through the use of assistive technology.

The component provides for the development, implementation and evaluation of a comprehensive service delivery system whereby persons with disabilities residing in all areas of the state will be able to access assistive technology services and/or devices. For this program to be successful, public, private-for-profit and non-profit agencies and providers must come together to provide services/devices and reduce duplication and delays.

Assistive Technology services include:

- Contracted services to assist division staff in researching and evaluating assistive technology for consumers.
- Public Awareness, Outreach and Training training to governmental agencies, private businesses, community
- organizations and employers concerning the use of assistive technology by individuals to promote personal independence and employment.

Low Interest Loan Program – Guaranteed low interest loans to individuals with disabilities, administered by the • division in cooperation with Northrim Bank in Alaska, for purchase of assistive technology.

#### **Key Component Challenges**

The Assistive Technology Act of 2004 was signed into law by President Bush on October 25, 2004. The Division is responsible for interpreting changes in the law as it may apply to the Alaska Assistive Technology program and implementing these changes through the development of a State Plan for Assistive Technology Services.

#### Significant Changes in Results to be Delivered in FY2008

As a result of the Assistive Technology Act of 2004, we are now in the second year of implementing the state plan for assistive technology. The division will contract for the majority of the statewide assistive technology services through ATLA (Assistive Technologies of Alaska). Although the original plan included utilizing ATLA to determine benchmarks for the current year so the division could establish measurable goals, this objective had to be deferred to FY08. This occurred because the federal Rehabilitation Services Administration was not able to define the specific data to collect or provide the data collecting mechanism as originally planned.

#### Major Component Accomplishments in 2006

During the past year the major focus of our assistive technology activities has been through our contract with the

Assistive Technology Library of Alaska (ATLA) in the areas of education, community services, employment and information technology. There has been an increase in the access and acquisition of assistive technology through significant awareness activities and events, demonstrations of equipment, training, technical assistance and collaboration and coordination with an increasing number of partners.

Specific sub-components of this include:

Successful implementation of Assistive Technology (AT) web-based "swap shop" throughout Alaska. This internet based exchange program received approximately 10,000 "hits" from consumers who are selling, swapping or giving away AT items. There is a current listing of approximately 140 items on this website;

Completed inventorying current loan closets of durable medical equipment to finalize an Alaska's first online listing;

Completed first step in developing a collaborative statewide loan system for AT devices and software to be used by all Alaskans (with or without disabilities);

Successfully completed AT training for approximately 50 groups and 320 individuals statewide;

Completed an AT handbook publication for Alaskan businesses for future employer training;

Increased AT awareness throughout Alaska by utilizing marketing materials, broadcasting 41 statewide television commercials and numerous presentations at Chamber of Commerce, civic organizations, booths at health fairs and conferences;

Successfully worked with 12 organizations to put on the ADA Celebration in July 2006, the Mentoring Project with the Anchorage Municipality, and began planning phase for our statewide AT conference in August 2007.
