Department of Labor and Workforce Development Adult Basic Education Component Budget Summary

Component: Adult Basic Education

Contribution to Department's Mission

The Adult Basic Education component contributes to the department's mission by providing adult learners instruction in the basic skills of reading, writing, mathematics, English as a Second Language (ESL), and GED (General Educational Development) preparation and testing.

Core Services

The Adult Basic Education (ABE) Program prepares Alaskans for employment by providing instruction in the basic skills of reading, writing, mathematics, and General Educational Development (GED) preparation and testing through grantees. Emphasis is given to integrating practical life skills and workplace readiness skills into instruction.

Adult students also receive instruction in speaking, reading, and writing English as a Second Language with an emphasis on civics education and the language competency needed for most entry-level service positions.

GED test administration occurs in 25 GED Testing Centers located statewide and GED transcript requests are filled for graduates seeking employment and/or entry into post-secondary education.

Key Component Challenges

The demand for ABE services continues to grow. The emphasis on basic skills education includes a growing demand to provide ABE instruction for Alaskans preparing to enter apprenticeship and training programs.

Federally mandated data quality and reporting requirements necessitate a high degree of reliability and validity with indepth analysis. To meet the mandated requirements, the ABE program utilizes three databases: a computerized ABE student database, a GED examinee database, and an on-line basic skills assessment database. The ongoing challenge is to maintain, monitor, and update the databases while providing training to the regional ABE program staff who use the databases.

GED graduates require copies of their GED transcripts for employment and post-secondary educational opportunities. This office maintains transcripts for all Alaskan GED graduates dating back to 1948. Current transcripts and those from recent years are available electronically; the older ones are not. The program has not yet determined how best to convert the older transcripts to an electronic format or how to fund the conversion without impacting services.

Significant Changes in Results to be Delivered in FY2008

Continued implementation of a standardized, web-based student assessment instrument will increase the reliability and validity of the students' basic skills evaluation and provide a more accurate assessment. As a result, the regional ABE programs will better assign learning activities enabling students to achieve their educational and employment goals more quickly.

Major Component Accomplishments in 2006

A total of 1,846 GED diplomas were awarded in FY2006.

During FY2006, a total of 2,102 Alaskan adults completed all five of the tests in the GED test battery, and 88% of them successfully passed their exams and earned their GEDs.

During FY2006, a total of 81.6% of ABE adult students demonstrated increased basic skills knowledge.

The State ABE/GED office continues to process over 2,000 GED transcript requests per year for past graduates seeking employment and acceptance into post-secondary training.
