## Department of Labor and Workforce Development Yuut Elitnaurviat, Inc. People's Learning Center Operations Grant Component Budget Summary

#### Component: Yuut Elitnaurviat, Inc. People's Learning Center Operations Grant

#### **Contribution to Department's Mission**

The Yuut Elitnaurviat People's Learning Center component contributes to the mission of the department by providing industry specific training opportunities to the Yukon Kuskokwim (YK) Delta.

This is a pass-through grant. The department has no authority over the management of the program.

#### **Core Services**

Upon completion of all phases of construction Yuut Elitnaurviat will be a career learning center for adults and high school students with a focus on health, education including early childhood, aviation, and construction (to include Mining and Millwright programs), which are the main industries in the region.

Students who go to the Yuut Elitnaurviat center will have opportunities to receive college and high school credit. GED services will also be offered.

The facility will also feature a 44-bed dormitory, a child care/education center, and links to job opportunities throughout the region.

#### Key Component Challenges

The primary challenge is to secure funding to complete all phases of facility construction.

#### Significant Changes in Results to be Delivered in FY2008

The Yuut Elitnaurviat People's Learning Center is currently working to expand programs to train Alaskans in the areas of mining and the energy industry.

#### **Major Component Accomplishments in 2006**

The construction training facility has been completed at the regional learning center, located in Bethel. The next phase of construction which includes offices and dormitories is scheduled for completion in late 2007.

The federally registered YK Delta Apprenticeship program is in the second year of a four year program with 33 apprentices in the fields of carpentry, plumbing and electrical. All 33 apprentices have positions with the five participating employers to gain the 8,000 hours of on the job training in addition to the 144 hours of classroom training required per year for completion of the apprentice program.

The Yuut Elitnaurviat People's Learning Center completed two construction academy sessions during the last year consisting of 27 individuals. The goal of these three week academies is to provide individuals with entry level training in carpentry skills as well as basic construction safety in order to facilitate employment within the construction industry in the YK Delta Region.
