### **Component: Narcotics Task Force**

#### **Contribution to Department's Mission**

Preserve public peace, protect life, property, and resources.

#### **Core Services**

The mostly federally funded Narcotics Task Force (NTF) is organizationally part of the Alaska Bureau of Alcohol and Drug Enforcement (ABADE), which investigates trafficking of controlled substances and illegal alcohol throughout the state. The unit is budgeted as a separate component to allow expenditure of the federal grant funds to be easily tracked.

The goal of ABADE is to solve sophisticated criminal cases involving controlled substances and illegal alcohol on a statewide basis through detection, apprehension, and assistance in the prosecution of individuals suspected of violating controlled substances law and state alcohol laws.

## **Key Component Challenges**

The ABADE has taken the lead role in almost all regions of the state in coordinating the investigative efforts involving illegal alcohol and drugs.

Five members of the ABADE program are dedicated to the interdiction and investigation of illegal alcohol shipments into villages that have voted to exercise their local option to either limit or prohibit the possession, sale, bartering, and importation of alcoholic beverages.

The remaining members of the ABADE are involved in investigating drug and illegal alcohol violations across the state. The unit works closely with a multitude of other agencies in nearly all locations in order to accomplish its mission.

Federal funding from the Justice Assistance Grants (JAG) program has significantly declined over the past three years. In federal fiscal year (FFY) 2005, Congress passed legislation implementing the JAG program which replaced the Byrne Formula and Local Law Enforcement Block Grant programs. Federal funding appropriated for JAG was significantly less than the Byrne funding in FFY2004. The President's FFY2006 budget proposal had no funding for the JAG program, however Congress chose to continue the program in FFY2006, albeit at reduced funding levels. The same scenario is playing out in the FFY2007 budget. The final federal JAG budget will likely be known around December 1, 2006.

In the state FY2007 budget, the department received general fund appropriations of \$1,393,200 to offset reductions in federal JAG funds for drug enforcement. This appropriation has a contingency clause that specifies that if JAG funding exceeds a certain amount, roughly the amount of JAG funding for Alaska in the FFY2005 budget, the general fund appropriation is reduced by a corresponding amount. The intent of this unusual appropriation was to ensure that funds for state and local drug enforcement efforts would not be significantly diminished because of the decline in federal funding. This language needs to be continued in state FY2008.

#### Significant Changes in Results to be Delivered in FY2008

The JAG funds that go specifically to ABADE are used for the most part to pay for narcotics investigators. In the event that any reduction in FFY2008JAG funds is not again replaced with general funds, ABADE will face the elimination of up to six of its ten JAG-funded positions. The only alternative would be to reduce allocations to other components to make up the shortfall.

#### **Major Component Accomplishments in 2006**

The unit continues its aggressive pursuit of all leads concerning clandestine methamphetamine laboratories in order to keep this problem from spreading beyond the areas that are already feeling its effects.

During FY2002, the Alaska Interdiction Task Force, made up of members from AST, Airport Safety, and the Alaska National Guard Counter Drug Support Program, entered into a formal agreement to participate in a Drug Enforcement Administration (DEA) task force. The task force is dedicated to intercepting illegal drugs and alcohol as the substances are transported throughout the state and to assist in the conviction of offenders.

Six units of local government (Bethel, Fairbanks, Hooper Bay, Kotzebue, Sitka, and Unalaska) were awarded grants to support local law enforcement's participation in a statewide multi-jurisdictional drug task force. This enabled law enforcement agencies in these different jurisdictions to work together as a single entity with improved communication, shared intelligence, and coordination of activities, allowing for more efficient use of resources and targeting of offenders whose activities cross over jurisdictional boundaries.
