The purpose of my letter is to express strong support for Copper Valley Electric projects included on page 38 of the capital budget (SB 221). The four projects total \$5 million and will be used as follows:

- \$2 million to match a federal grant already in hand to upgrade the Glennallen Plant

- \$500,000 to upgrade the Valdez substation
- \$1.5 million to reimburse the co-op for money spent years ago evaluating a transmission line connection to the Railbelt Grid which did not pan out
