Project Description/Justification:

To defray the cost of transition to city or borough government and to provide for interim government operations, each city incorporated, or each borough or unified municipality incorporated after December 31, 1985, is entitled to an organization grant under Alaska Statute 29.05.180 - .200.

Each city or second class city incorporated after December 31, 1985, is entitled to an organization grant as follows:

- (1) \$50,000 for the first full or partial fiscal year after incorporation; and
- (2) \$25,000 for the second fiscal year after incorporation

Each borough or unified municipality incorporated after December 31, 1985, is entitled to organization grants as follows:

- (1) \$300,000 for the municipality's first full or partial fiscal year;
- (2) \$200,000 for the municipality's second fiscal year; and
- (3) \$100,000 for the municipality's third fiscal year.

It is anticipated that the City of Wrangell may incorporate in fiscal year 2008. If so, the first year of funding will be requested as an FY08 Supplemental. The second year's funding (FY09) for Wrangell has been requested in this project.

The City of Petersburg may incorporate in fiscal year 2009. Under current Alaska Statute 29.05.180 - .200, it would be entitled to \$600,000 over three years. However, it is anticipated that the City of Petersburg may not request funding so it is not being requested at this time. If funding is requested, it will be included in a future capital request.
