**Brief Summary and Statement of Need:**

Deferred maintenance request for the Bethel Readiness Center in Bethel includes replacement of the outside stairwell, replacement of exterior fire escape, replacement of the above ground fuel tank, and replacement of restroom stalls. This amendment changes the ASLC Bonds fund source to the Alaska Capital Income Fund since credit market concerns preclude the ASLC from returning capital to the state in FY09.

**Project Description/Justification:**
