Project Description/Justification:

The Department of Health and Social Services is implementing in-depth impact analysis and requirements assessments for its health care programs, operations, computer systems and policies and procedures to comply with new federal regulations concerning electronic transmission, privacy and security of patient and health care information. The level of federal reimbursement for this project has been higher than expected. This request is to allow the Department to use federal reimbursement up to the level provided for the project.

There are several areas concerning HIPAA regulation that continue to require funding. The Security Assessment project has two more phases to complete with contracted security expert guidance as well as future remediation efforts once the assessment has been completed. It will be necessary for remediation efforts to use consultant and contracted services. However, Information Technology staff time and knowledge is also required. The current HIPAA security model calls for a Department Security Officer and other salaried staff working on HIPAA issues, including the HIPAA Privacy Officer and HIPAA Privacy Assistant. Hardware, software tools, and other equipment will need to be purchased during the remediation effort, some of which have been generally identified but require further evaluation and specification during the remediation process.

The Department expects to spend approximately \$500,000 in consultant and contractor costs to finish the Security Assessment and remediate the assessment's findings. The cost for hardware, software, and equipment is estimated at \$500,000.
