**Project Description/Justification:**

UAS Anderson Building Renovation

This project is a consequence of two circumstances. One is the move of the UAF School of Fisheries and Ocean Sciences out of the Anderson Building to a new Lena Point facility in 2008. The second circumstance is the 30 year old condition of the Anderson Building and the need to reconfigure the space for new technical and academic needs. The project will include classroom, laboratory, faculty office, and research spaces (\$7.2M), as well as construction of a pedestrian crossing of Glacier Highway (\$2M), acquisition of adjacent property (\$.5M) and construction of additional parking (\$.5M). Funding received in FY08 (\$500K) will provide for planning and begin design.
