The University of Alaska Fairbanks, the nation's northernmost Land, Sea, and Space Grant university and international research center, advances and disseminates knowledge through teaching, research, and public service with an emphasis on Alaska, the circumpolar North, and their diverse peoples. UAF - America's arctic university - promotes academic excellence, student success and lifelong learning.

Core Services

The Fairbanks campus is the major intellectual and cultural center for Interior Alaska. In addition to its wide array of developmental, certificate, associate, baccalaureate and professional programs, UAF is a center for graduate education. As a major center for research and scholarship, UAF is committed to the integration of teaching, research, creative activity and public service. The physical and natural sciences are emphasized, as are engineering programs that focus on northern environments. A major center for the study of natural resources, including minerals, forestry, wildlife, geology, agriculture, fisheries and ocean sciences and their associated economics, UAF is also a recognized leader in multicultural understanding, research and education on rural health problems, and cross-cultural interaction in the human service professions. It is also the state's center for the study of Alaska Native cultures and languages.

UAF is Alaska's research university and has an active program of basic and applied research that is carried out primarily at the Fairbanks campus. It enjoys both a national and international reputation, particularly in the area of circumpolar research.

Key Component Challenges

Persist on attainment of enrollment management (EM) goals and objectives, in particular establishing clear connections between academic unit EM plans and overall UAF EM goals.

Increase recruitment of well-qualified students, including transfer students and Alaska Scholars.

Continue preparations for implementation of new admissions standards in fall of 2008.

Continue to diversify funding sources

Begin process for Accreditation Self-Study (2011)

Finalize revisions of the Academic Development Plan

Persist in efforts to obtain funding for BIOS. This year's BOR proposal for BIOS will present a phased funding approach to spread the requirement over multiple funding years.

Continue to evaluate administrative procedures and practices to eliminate inefficiencies and redundancies.

Space continues to be a significant challenge. The backlog of deferred maintenance, obsolete facilities (particularly research laboratories) and lack of adequate space is ongoing

Significant Changes in Results to be Delivered in FY2009

The FY09 Budget request includes general fund support for our rapidly expanding Engineering program.

Retention for first-time, full-time freshmen was 67 percent in FY07, representing a 3 percent increase over FY06. In FY09 UAF is requesting operating funds to expand these efforts at improving retention, with a focus on increasing graduation rates by several percentage points per year, as well as first-year retention.

An 8 percent growth is anticipated in research expenditures, although lack of space is limiting research growth. In FY09 the BOR has requested operating funds to enhance capacity in biomedical, climate, transportation, fisheries, and computer research, which we anticipate will promote at least a five-fold return on investment in the form of external research funding. The FY09 BOR capital budget request top priority for new construction is BIOS, a combined research and teaching facility that will permit UAF to remain competitive in research beyond 2010.

UAF will be continuing to change the focus of outreach and research programs delivered by the Cooperative Extension Service and the Agriculture and Forestry Experiment Station. An external review in Fall, 2007, will inform these changes. New, expanding, or improving programs will include alternative energy and energy conservation, new approaches to agriculture including the use of controlled environments, and further development of value-added food products.

Major Component Accomplishments in 2007

Teaching and Learning for Student Success

College of Liberal Arts (CLA)

The applied linguistics program at UAF received a three-year, \$1.3-million federal grant to support a project that will offer K-12 teachers in Southwest Alaska graduate-level training in second-language acquisition.

CLA faculty member Terrence Cole received the Governor's Award for the Humanities. Cole, a history professor and director of UAF's Office of Public History, is the author of multiple books on Alaska history and a recognized specialist on the Alaska gold rush.

College of Natural Sciences and Mathematics (CNSM)

Katey Walter, Biology and Wildlife PhD graduate was awarded the nation's most prestigious honor for her doctoral dissertation from the Council of Graduate Schools.

A survey of faculty productivity conducted by Academic Analytics ranked UAF in the top ten in the areas of atmospheric science and environmental sciences. Many CNSM faculty are a part of these programs.

College of Rural and Community Development (CRCD)

The Rural Alaska Honors Institute marked its 25th year with a record number of students (69) coming from more than three-dozen communities across Alaska. This summer—as part of the International Polar Year—a dozen students studied with scientists at the Arctic Science Consortium in Barrow. A report by the American Institutes for Research through the National Science Foundation found that Rural Alaska Native students in the UA system are nearly twice as likely to earn a bachelor's degree, than those who did not attend RAHI.

School of Education (SOED)

SOE faculty and administration have been active participants in the cross-campus, multi-disciplinary workgroup to establish an Indigenous-focused Ph.D. program.

School of Management (SOM)

School of Management undergraduate business seniors who have taken the Educational Testing Service (ETS) major field outcomes assessment test in business, the standard assessment test for the nation's business majors, ranked in the 90th percentile when compared to the 513 participating schools on a school-by-school basis.

SOM was reaccredited by the Association to Advance Collegiate Schools of Business (AACSB International). SOM continues to hold on to its dual accreditation (SOM and the Accounting department) a distinction that is held by less than 5 percent of business school world-wide (168 schools).

Enrollment and Retention

College of Engineering and Mines

Acceptances in CEM programs are up over 50 percent compared to a year ago, an apparent result of the targeted recruitment program.

College of Natural Sciences and Mathematics

The UAF Alaska Native Science and Engineering Program (ANSEP) had another very successful year with 80 students in fall 2006. The retention rates in the program remain over 90percent.

Community Engagement and Economic Development

Summer Sessions

The summer community outreach program was expanded, including a live national broadcast of Talk of the Nation: Science Friday; the "Discovering Alaska" lecture series; and the first Alaska Book Festival, a two-day event with thirty authors and community participation of over 300.

University of Alaska Museum of the North

After more than four years of active construction, work on the museum's expansion was completed during FY07 and all areas of the expansion became fully-operational.

The museum expansion was featured in Architectural Record, Time Asia and several major domestic daily newspapers through the Associated Press. The project won an honor award from the Minnesota Chapter of the American Institute of Architects. The museum was awarded the Governor's Award for the Arts (arts organization category) in fall 2006; this award recognized both the architecture and new exhibit galleries as well as the museum's long-term contributions to art and culture in Alaska.

Advancement and Philanthropy

School of Management

The SOM received \$164.0 from Flint Hills to create a mobile Experimental Economics Laboratory.

School of Fisheries and Ocean Sciences (SFOS)

SFOS received a \$5 million Rasmuson Foundation Fisheries Enhancement Grant.

Faculty and Staff Development

The Office of Faculty Development offered more than four-dozen workshops on teaching and assessment, as well as co-hosted an adult learners conference, held in conjunction with the College of Rural and Community Development's health program. In addition, 44 faculty members earned more than \$ 36.0 in travel grants for professional development. United Academics provided a portion of matching funds.
