Brief Summary and Statement of Need:

This project was moved to the Governor's FY2010 Supplemental Deferred Maintenance bill. Funding is needed for continued deferred maintenance in the Non-PBF group of facilities located in Juneau. Additional funding is also needed for deferred maintenance in the Public Building group of facilities which include the Atwood Building and Linny Pacillo Parking Garage in Anchorage, the Fairbanks Regional Office Building, the Juneau State Office Building, the Dimond Courthouse, Alaska Office Building, Douglas Island Building, Court Plaza Building, Juneau Public Safety Building, and the Community Building in Juneau, and the Palmer State Office Building.
