Explanation of Other Funds:

The school district will provide supplies for cement and other needs in the installation of the playground equipment. Local community members will be asked to do the actual installation of the equipment.

Detailed Project Description and Justification:

This project will allow the installation of playground equipment for elementary students during the school year where there is nothing in place now. There has never been any playground equipment in Angoon at the elementary school. Students are confined to the gym from the start of the school year to the end of the school year. Parents, staff, district maintenance personnel and even the superintendent will assemble and install the playground equipment. A manufacturers representative will be paid to oversee and direct the work done by the various groups mentioned to insure that the installation is done according to the manufacturers specifications. A per diem will be paid to that individual along with transportation costs to get that person to and from Angoon. This playground will allow the community usage of the area in the evenings and during summers when the school is not in session. Benches will be added for community members to sit at when they take their children or grandchildren to the playground during non-school hours. Playgrounds like this are common across the United States and in many, many other Alaska school sites. Unfortunately, the Chatham School District does not have the funds to purchase and install this within its normal yearly operating budget.

If these two grant applications are approved the school's and their communities will have playground equipment that can be used by their young children for years to come.

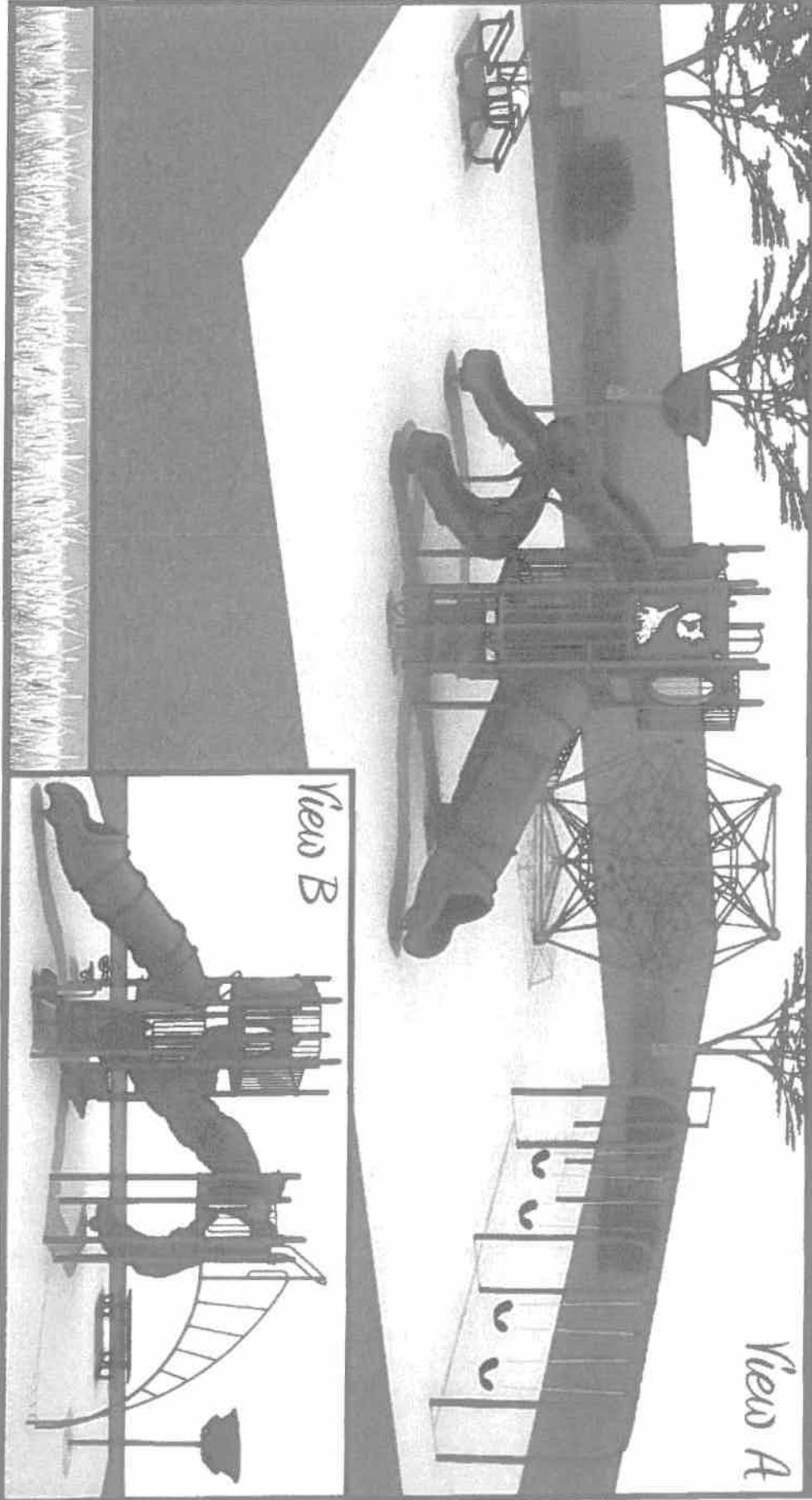

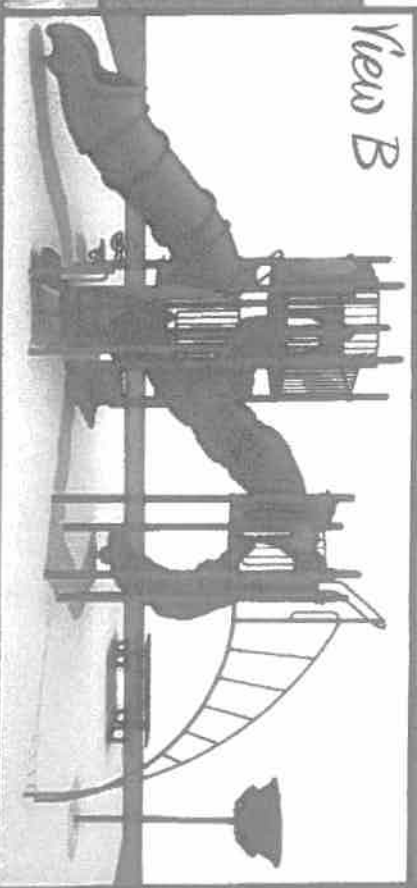

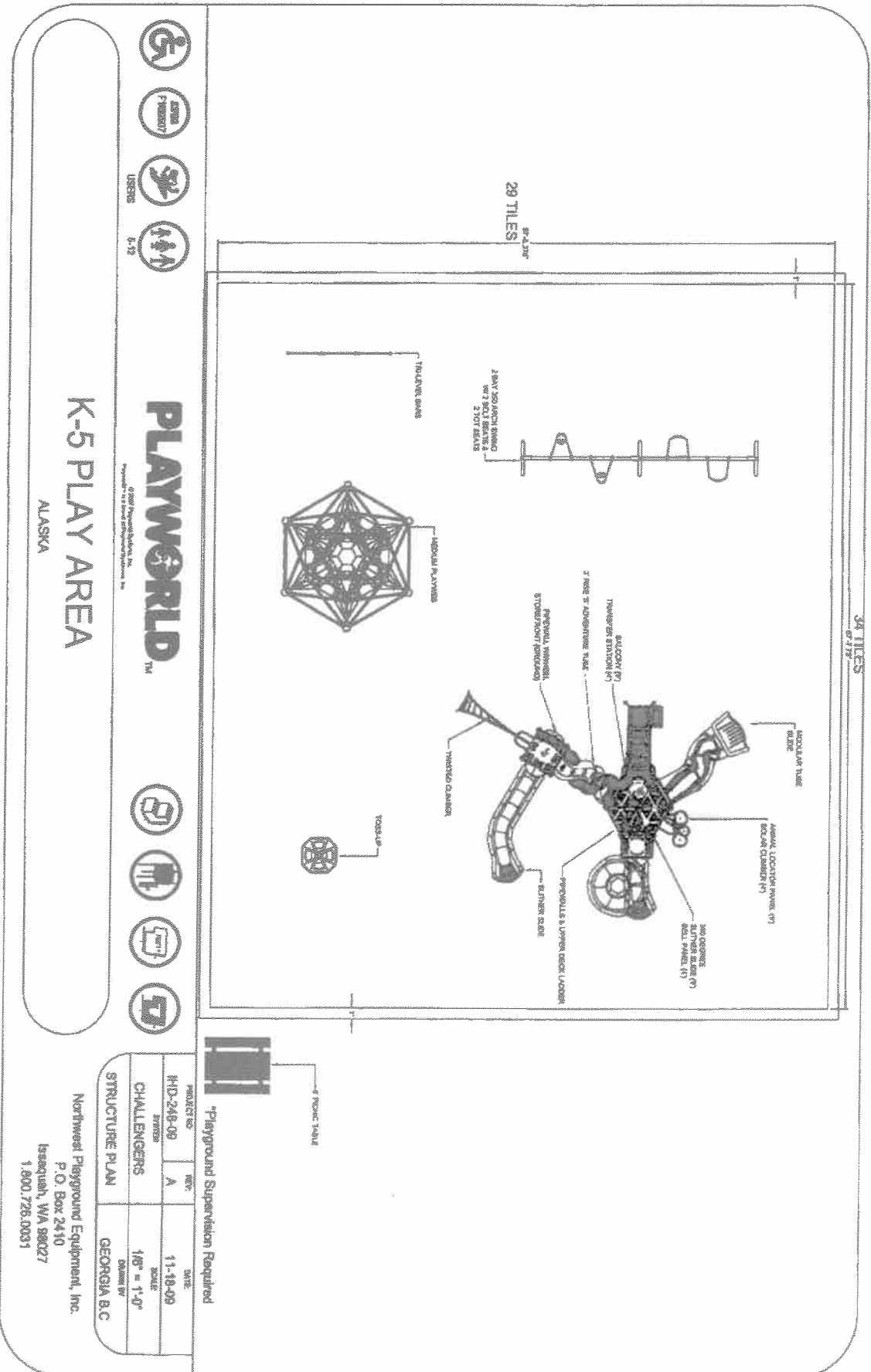
