**Project Description/Justification:**

**1. Alaska's Floodplain and Erosion Management Program:** This program's mission is to reduce public and private sector damage and losses from flooding and erosion. This is accomplished by providing communities that participate in the National Flood Insurance Program (NFIP) with technical assistance and grants for the initial planning and subsequent construction of flood mitigation projects.

DCCED and the Federal Emergency Management Agency's (FEMA) Flood Mitigation Assistance program (FMAP) personnel are actively working with the communities on every phase of potential projects -- applying for a planning grant, approving the resulting plan, approving a construction grant or contract and approving the completed project. This program has existed since 1997. FEMA provides funding for, Community Assistance, Technical Assistance, and assistance to specific communities. Historically, total funding has been \$400.0, with FEMA providing \$300.0 and requiring \$100.0 (25% match) from the state. In FY11, Commerce anticipates \$300.0 from FEMA with required General Fund match of \$100.0.

**2. Coastal Zone Management Program:** DCCED is required by Alaska State law (AS 44.33.781) to conduct a program of research, training, and technical assistance necessary for the development, implementation and maintenance of district coastal management plans under AS 46.40. As part of its technical assistance to coastal resource districts, DCCED awards and manages Alaska Coastal Management Program (ACMP) grant funds.

The program ranges from \$1,000.0 to \$1,300.0 annually and is funded with Capital Improvement Receipts (CIP) from the Department of Natural Resources (DNR). DNR receives its funding from the U.S. Department of Commerce, National Ocean and Atmospheric Agency. Each grantee provides 20% to 50% of the project's cost.

In FY11, Commerce anticipates \$1,000.0 from the Department of Natural Resources with required General Fund match of \$120.0.

**3. Community Mapping:** In FY11, we anticipate receiving funding for community mapping projects. We expect to receive \$350.0 to prepare maps for the Alaska Highway zone of the interior region, which will complete our planned community mapping activities. FEMA requires a 25% match of state funds of \$87.5.

**4. Cooperating Technical Partners (CTP) Program:** This program provides funds to support technical mapping-related activities. CTP is serving as a successor program to the Map Modernization program, which supported the production of Digital Flood Insurance Rate Maps (D-FIRMs). Funding from FEMA is anticipated to be approximately \$75.0 per year for program staffing, with no financial matching requirement.

**5. Coastal Impact Assistance Program Administrative Funds:** \$153.5 I/A is anticipated for FY11.

**6. Alaska Sustainable Salmon Fund Program:** Funding provided by U.S. Department of Commerce - National Oceanographic and Atmospheric Administration (NOAA) through Governor's Office and Department of Fish & Game. The purpose is to develop public salmon information and educational programs through competitive grant program. \$1,000.0 I/A is anticipated for FY11.
