Major Component Accomplishments in 2009

A protocol has been developed for the identification, prevention and treatment of the H1N1 virus infection. Plans are in place to vaccinate both the inmate population and employees.

A respiratory protection plan has been implemented and the medical staff has been fit-tested for the N 95 surgical mask in an effort to prevent the spread of airborne infections.

A focus group has been created to study and modify an electronic medical record system.

Implementation of a data surveillance system to track Methicillin-Resistant Staphylococcus Aureus (MRSA) infections.

Began the process of updating and standardizing inmate physical health policy and procedures.
