**Project Description/Justification:**

This project funds the replacement of law enforcement equipment for the Division of Alaska State Troopers.

Annual funding is needed to provide the primary law enforcement organization in the state with basic law enforcement equipment necessary for state troopers to provide service to the public. Equipment regularly needs replacement because of constant use and normal wear and tear.

This project will provide funding for the following types of equipment; however, other types of equipment may be purchased if deemed more mission critical than these items at the time of purchase.

**New and replacement electronic and office equipment: \$300,000**

This category of equipment includes radar units, printers, scanners, digital recorders, digital cameras, digital video, computer software, and office equipment for use in crime scene and other documentation and evidence gathering. This category also includes the replacement of antiquated and irreparable office furniture such as desks and chairs.

**Law enforcement equipment: \$200,000**

This request would purchase radar units for vehicle speed enforcement, total station (instruments used for accident and crime scene documentation and mapping), all terrain vehicles (ATV's), snow machines, and specialized emergency response team (SERT) equipment.
