Brief Summary and Statement of Need:

Project will include the build-out of North Terminal vacant space in order to relocate the badging office. Badging is a required Transportation Security Administration (TSA) function needing accommodation. Space larger than the current facility is required due to the increased badging requirements mandated by TSA. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

Project Description/Justification:

This project will consist of building-out approximately 1,845 square feet of vacant staff office space in the north end of the North Terminal, level 1, for the badge office staff and visitors. The function of the Badging Office is to accommodate training, fingerprinting, criminal history records check processing, and badging / vehicle permit functions as required by 49CFR 1542.209, 211, and 213. The expanded badge office will allow for higher efficiency to accommodate the increased volume of badge applicants due to new TSA requirements of re-badging employees more frequently.

The Badging Office is currently located in a 1,510 square foot temporary structure adjacent to the Airport Police and Fire building. This temporary structure has surpassed the 5-year temporary occupancy permit by the Municipality of Anchorage (MOA). New TSA regulations (Order 1542-04-08f) require additional training requirements for badge holders which proportionally increase demands on the current badging facility.
