Reconstruct and widen the street from Jeff Davis Street to the end of the pavement. Stage 3 extends from Whale Park to the Industrial Park at Sawmill Cove. Increase pavement width, improve the roadside environment and add a pedestrian facility on the water side. Roadside drainage opposite the Industrial Park also needs to be improved. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

**Additional Information / Prior Funding History:**

FY2009 - \$10,800,000 (GO Bonds); FY2006 - \$5,200,000; FY2005 - \$2,500,000.

**Project Description/Justification:**

Construction of a wider road with paved shoulders and pedestrian accommodations as appropriate. Traffic volumes on this aging pavement exceed 2,000 vehicles per day.

Upgrading and widening this arterial supports the Department's mission of improving mobility of people and goods. This route is the only surface link to the eastern side of Sitka, including the Industrial Park at Sawmill Cove. Growth in this part of Sitka has been substantial, and highway improvements are lagging behind. Of greatest concern are the narrow pavement width and lack of shoulders.
