Build a new public safety building-holding cells, dispatcher area, court office, VPSO office, State Troopers office, fire hall.

Detailed Project Description and Justification:

It will improve safety and efficiency during an emergency while also allowing a safe jail and adequate space of a jury and trial. Other benefits of the public safety building will include office space, safe adequate storage space, adequate rest rooms and showers and security for all police, state troopers, fire, state court employees, and search and rescue needs. Most of all, it will ensure that workers have ready access to needed equipment during an emergency. It will provide securely locked storage areas for vehicles, supplies and other property. Better equipment like fire safe boots, clothes, fire safe coats, night vision goggles, radios to help the workers have all the things needed to do the job right. Also, it will allow us to install a community alert emergency siren which will help workers respond faster to emergencies and alert the entire community to danger. With a better location and enlarging the outdoor storage space it will improve accessibility to equipment and provide storage for other emergency supplies like fuel, inflatable shelters, generators, extra food, water, and medical kits. The City of Unalakleet's jail facility is less than adequate, not enough jail cells, poor design, wire cell doors in need of repair, currently our liability to house prisoners is very high. The current building where the jail is located is over 30 years old, the court house is around 25 years old and fire truck is parked in a building that is over 40 years old. Another benefit of the new building is to have office space for the Alaska Court Magistrate. Along with the office space is an area where a jury can deliberate during a trial. The city feels that for safety and efficiency reasons it would be nice to have all entities of the community such as the village police officers, Alaska State Troopers, Village Public Safety officers, Alaska Court Magistrate, search and rescue and fire department all located in one area. Right now all of the above entities are spread out in our community and communication is a problem. The City Council of Unalakleet is looking into purchasing a new fire truck along with a quad four wheeler for the fire department and is in need of more building space.

RE: New Public Safety Building Rough Order of Magnitude Estimate – Unalakleet, AK

Dear Mayor Johnson;

Per your request Bethel Services Inc. offers the following Rough Order of Magnitude (ROM) estimate for a new public safety building to be designed and constructed in Unalakleet, Alaska.

The assumptions used in calculating this ROM are as follows:

- Multi-purpose facility to house: emergency response personnel for local and state public safety officers; holding cells for those under arrest; holding cell for inebriates; courthouse; jury deliberation room; storage and shop space for emergency response equipment; and other administrative functions associated with public safety for the community of Unalakleet.
- Land costs are excluded as it is assumed the building site is currently in possession of the City.
- Utilities are adjacent to existing parcel of land.
- Square foot of facility to be approximately 7,000 square feet.

Design and engineering	\$ 300,000
Construction	2,900,000
Administrative expenses*	<u>200,000</u>
Total estimated funds required	\$3,400,000

**Costs anticipated to be borne by Village of Unalakleet to manage project during the design and build portions of the project.*

This projected cost is intended to serve as a rough order of magnitude estimate only based on current design and construction costs of similar facilities in similar locations in the Western region of Alaska to serve as a baseline for funding determination. It is not a complete construction proposal and final pricing would be determined at such time if and when a complete bid package is prepared and submitted to the owner.
