**Project Description/Justification:**

Covenant House Alaska (CHA) is part of a statewide network of private, not-for-profit and government entities working together to ensure the safety and success of Alaska's vulnerable youth. The requested project funds will provide continued funding to launch the construction of a new shelter for Alaska's youth.

There are still gaps in the continuum of care model for Alaska's kids. Youth who are leaving foster care have few choices and support systems to transition to healthy, safe and productive housing and lifestyle situations. Approximately 60% of the kids coming to CHA are from the foster care system. The Crisis Center experienced a 58% increase in average daily census over three years.

CHA has provided services to these homeless, runaway, and at-risk youth ages 13-20 since 1988. Services are provided through four main programs: the Crisis Center, the Community Services Center, Transitional Living Programs and access to primary healthcare. The services are free and include case management, family mediation, health care, employment, education, and mental health and substance abuse referrals. If homeless youth are connect to the right resources to obtain safety, housing, food and medical care then they may go on to finish their education, obtain job and life readiness skills and become healthy, self-sufficient, contributing members of our community.

The current need is to increase capacity while decreasing the number of youth in each room, to have a separate intake room, a private family mediation space, counseling offices, increase program service space, and have isolation rooms to meet the medical needs of Alaskan youth.

The parent company of Covenant House Alaska has provided over \$21 million to care for Alaskan kids. Continued access to safe housing, supportive adults, job development and continued education is essential to the success of Alaska's youth.
