Parks contracts with private sector contractors for this work wherever possible, and some repairs to cabins, volunteer housing and picnic shelters is done with volunteer labor.

threat to the public. Not funding this project means some potentially major damage and safety issues in parks do not get repaired, eventually leading to major degradation and deterioration of facilities. Poorly maintained park facilities can be a health and safety issue for visitors and may result in unexpected park closures and a loss of fee-paying visitors.

Whether park users are from Alaska or Outside, local communities benefit greatly from the economic impact of park visitors buying groceries, gas, fishing tackle, souvenirs, restaurant meals, showers, guidebooks, fishing guides, and sightseeing tours. To continue attracting these visitors, facilities must be repaired and maintained and meet basic health and safety requirements.
