Protect Workers

Statutory and Regulatory Assistance and Enforcement to protect Alaska's workers. This includes the department's wage and child labor law enforcement, workplace safety compliance and enforcement, mechanical device inspection, and overseeing State of Alaska Americans with Disabilities Act compliance.

Workforce Development

Workforce Development to support Alaska hire and economic development. This includes the department's employment services, adult basic education, business partnerships, career and technical education and training, and vocational rehabilitation services.

Income Replacement

Income replacement for injured, unemployed and permanently disabled workers. This includes the department's Workers' Compensation, Unemployment Insurance and Disability Determination programs.

Protect Workers

The lost workday illness and injury rate per 100 employees was reduced by 9 percent from 1.76 in FY2009 to 1.6 in FY2010, and the target reduction was 2 percent.

- In FY2010, 348 employers were brought into compliance with the Workers' Compensation Act compared to 326 in FY2009 and 153 in FY2008.
- Left The FY2006 to FY2010 five-year average rate of workplace fatalities is 1.46 per

100,000 employees; up from 1.34 last year. This represents a 9 percent growth while the target was a 3 percent reduction.

Workforce Development

- The number of Alaska resident workers increased by 1.5 percent from 322,758 in calendar year 2007 to 327,532 in 2008, exceeding the target increase of 0.5 percent. Data for 2009 will be available in January, 2011.
- The nonresident hire rate for 2008 remained the same as the 2007 rate of 19.6 percent, but the target was a 2 percent reduction. Data for 2009 will be available in January, 2011.
- In FY2010, 52 percent of Workforce Investment System participants entered employment after exiting the system, a decrease of 5 percent from the prior year. The FY2010 target was a 1 percent increase.
- The number of individuals exiting the Vocational Rehabilitation program employed in FY2010 was 548, a 0.2 percent increase over the prior year. This exceeded the target of maintaining the prior year performance level.
- In FY2010, 93.9 percent of trainees entered employment after completing their training. This was below the target rate of 95 percent and below FY2009's rate of 95.9 percent.
- AVTEC's percentage of long-term (longer than six weeks) students who graduated in FY2010 was 84 percent (309 of 426). AVTEC has met or exceeded the target of 77 percent since FY2001.

Income Replacement

- Alaska's FY2009 wage replacement rate increased to 26.9 percent but is still under the national average of 36.1 percent.
- In FY2010, the number of claims filed with the Fishermen's Fund totaled 631, with 492 payments issued. The average time from receipt of a bill to bill payment was 63 days. This was primarily due to a complete turnover in staff. The target is 20 days, and the FY2009 performance level was 28 days.

Employment and Training Services continues to see an increase in resource room traffic due to higher numbers of unemployed Alaskans seeking work and workers transitioning from seasonal employment. Assisting people in group settings is one of the recent strategies being employed to address this challenge.

A significant increase in internet traffic to the Alaska Labor Exchange System has caused delays and outages resulting in frustration to users including job seekers, field staff, and employers. The department needs to find interim and long-term solutions to internet service and bandwidth concerns.

Federal grant continuity is an issue as the department relies heavily on federal funds (approximately 45 percent of its budget is supported with federal receipts). However many of these grants fluctuate from year to year and some come and go over time. This makes establishing a sustainable and consistent level of services a significant challenge. Alaska will receive less federal formula driven funding in FY2012 compared to other states with higher unemployment rates.

Another significant challenge is reaching workers where they live. Alaska is so geographically expansive that it is difficult to reach all areas, especially those outside the urban hubs, and outlying areas are often where the need is greatest. The department makes use of the infrastructure that exists in communities along with itinerant and distance delivery of services to reach as many residents as possible.

The Alaska Vocational Technical Center (AVTEC), within the department, provides postsecondary technical and vocational training to students from all areas of Alaska. Several of AVTEC's teaching, support and housing facilities are at the end of their use life and have Americans with Disabilities Act (ADA) and life and safety issues that require either substantial remediation or replacement. Also several programs are in need of either additional space or equipment to meet training needs.

Income Replacement

The recruitment of journey-level Disability Adjudicators and Vocational Rehabilitation Counselors remains an on-going challenge for the Division of Vocational Rehabilitation. To address this the division often hires individuals requiring skill development and, without access to relevant in-state educational programs, newly hired employees must engage in rigorous on-the-job training or take distance education courses. This places an additional burden on both the employee and the supervisor and diminishes the ability to provide services to clients.

Like many states, Alaska is struggling to keep up with the workload generated from paying unemployment insurance on multiple state and federal extended benefit programs. As of October 2010, Alaska's seasonally adjusted unemployment rate is 7.8 percent. Providing benefits is critical to unemployed workers and their communities.

Significant Changes in Results to be Delivered in FY2012

Protect Workers

The Division of Workers' Compensation will take steps to increase collection of Workers' Compensation Benefit Guaranty Fund fines, improving access of injured workers to workers' compensation benefits.

Workforce Development

Alaska Vocational Technical Center (AVTEC) will establish a registered nurse (RN) program with the capacity to train 20 RNs per year.

AVTEC will expand current maritime engineering program offerings with the capacity to train 60 mariners per year and qualify more Alaskans for Ocean Ranger positions on cruise ships traversing Alaskan waters. In 2010, five of 21 Ocean Rangers deployed were Alaskan residents.

Wage and Hour increased the number of on-site inspections by 50 percent from FY2009 to FY2010. At the same time the ratio of Alaska Employment Preferences Act (AEPA) violations to on-site inspections was reduced by 40 percent, which demonstrates that educational and deterrent efforts are promoting voluntary compliance.

Although qualified Boiler/Pressure Vessel inspectors and Elevator Inspectors continue to be in short supply in Alaska and nationwide the department Mechanical Inspection component is now fully-staffed. This allowed the component to reduce the backlog of overdue boiler inspections by 23 percent in FY2010 and the department is on-track to eliminate the backlog in the next three years.

The overall workplace illness and injury rate fell by 9 percent in FY2010 exceeding the target reduction of 2 percent.

The AKOSH Consultation program increased the number of on-site visits by 9 percent from 500 in FY2009 to 545 in FY2010. Also, AKOSH Enforcement conducted 20 percent more compliance inspections from 295 in FY2009 to 353 in FY2010.

Workforce Development

A total of 1,610 General Educational Development (GED) diplomas were awarded in FY2010.

The number of job seekers receiving staff assisted services through the Job Center network in FY2010 was 85,838, which is a 17 percent increase from 73,366 in FY2009.

The department coordinated partnership efforts toward the development of the Alaska Career and Technical Education (CTE) Plan published in August 2010.

The department provided \$2.3 million in Alaska Youth First Initiative funding in FY2010 that resulted in: 546 partnerships between grantees and various entities to provide and coordinate services; community based outreach through Alaska's Career Guide model to 19,776 students; employability skills training to 8,800 Alaskan youth; paid and unpaid work experiences to 1,125 youth; Academic/Training to 415 students; and externships for 46 teachers in target industries including health care, construction and resource development with an impact on over 2,200 students.

The federal Senior Community Service Employment Program for older workers in Alaska served 680 participants in FY2010, which is a 30 percent increase from the prior year. The federal participant placement goal was set at 23 percent and the final placement outcome for Alaska was 53.2 percent. The federal quarterly average earnings measure was \$6,803 and Alaska achieved an average of \$7,436.

529 individuals with significant physical and/or mental impairments that constituted barriers to employment were successfully employed for 90 days or more as a result of vocational rehabilitation services. The average hourly wage increased from \$12.98 to \$14.48.

The Alaska Vocational Technical Center trained 1,462 students in FY2010, with a graduation rate of 84 percent. The national average graduation rate is 70 percent.

Income Replacement

The Social Security Administration recognized the Alaska Disability Determinations Services (DDS) for its dedication and exemplary service to the citizens of Alaska by awarding the DDS management team with Regional Commissioner Citations.

Benefit Payment Control increased collection activities resulting in the recovery of approximately \$1.8 million in fraudulent unemployment insurance benefit overpayments and \$3.1 million in other overpaid benefits. Of this total, nearly \$1.1 million was recovered through Permanent Fund Dividend (PFD) levy requests submitted to the Department of Revenue.

The Alaska legislature changed the Unemployment Insurance calculation methodology in law and the department made related Alaska Administrative Code changes to comply with federal requirements of the American Recovery and Reinvestment Act (ARRA) of 2009. These changes qualified the department for Unemployment Compensation
