**Brief Summary and Statement of Need:**

This authority enables the Alaska International Airport System (AIAS) to accept capital contributions and receive reimbursement for work requested by airport tenants, private citizens, or other agencies on capital construction projects. Without this legislative authority, it is very difficult to include reimbursable work in projects. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

**Project Description/Justification:**

This authority enables the Alaska International Airport System (AIAS) to accept capital contributions and receive reimbursement for work requested by airport tenants, private citizens, or other agencies on capital construction projects. The net result is a substantial savings to the airport system and the airlines. This project does not affect the airlines rates and fees.

An example of a project that utilized this authority is the Taxiway T project. The primary tenant, Federal Express (Fed Ex) requested project changes prior to paving. Ted Stevens Anchorage International Airport (ANC) incorporated the requested changes into the project and Fed Ex then reimbursed ANC for the costs of their requested changes.

ANC has no accounting mechanism in place to accept reimbursement on work performed for third parties. Departmental regional authority has been used in the past; however, use of regional authority requires significant paperwork to incorporate the information into the AIAS accounting system. This legislative authority will greatly simplify the ability to be reimbursed and accurately track project expenditures.
