Project Description/Justification:

This program provides technical training to all department personnel. Through training, new technologies can be applied to planning, design, construction, maintenance and rehabilitation of Alaska's transportation infrastructure. In doing so, the quality of the State's transportation network is improved, thereby enhancing economic growth, public safety, quality of life, and environmental stewardship. High turnover in transportation personnel within the department, in local government and the private sector requires constant attention to training to ensure projects are planned, designed and constructed efficiently.

In calendar year (CY) 2008, we provided 70 training sessions to over 2,000 participants from state and local governments and other transportation personnel.

In CY 2009, we provided 111 training sessions to over 1,817 participants from state and local governments and other transportation personnel.
