Brief Summary and Statement of Need:

The State maintains approximately 253 rural system airports. The surfaces on these airports are continuously degrading due to time, use, settlement, wind and water erosion, moisture accumulation, and vegetation growth. Many of these airports are substandard and need minor surface improvements to improve their safety and capacity. The Department establishes priorities annually for the use of the minor surface improvement funding for projects at various rural airports statewide. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage, by improving the mobility of people and goods and by increasing private investment.

6. Painting and pavement marking.
7. Obstruction removal.
