Brief Summary and Statement of Need:

State match required for federal programs funded by the National Highway Transportation Safety Administration, the Federal Motor Carrier Safety Administration and the Federal Transit Administration. Transit program match funds provide 1/2 of the match required for local sponsors, including municipal & tribal governments and non-profit agencies, to use for public and community transportation needs. Not eligible for ferry and rail transportation. The non-federal match share varies from 9.03% to 50%, depending on funding program. This project contributes to the Department's Mission by improving the mobility of people and goods, reducing injuries, fatalities and property damage, and by increasing private investment.
