**Brief Summary and Statement of Need:**

This is a new FY2012 request that is needed for the project to be put out for bid. This project is being included in the FY2012 amended request due to changes in the scheduled obligation of federal funds to other DOT&PF projects that occurred after the release of the budget on December 15, 2010. The project is the initial stage of a large scale effort to address highway needs to support the construction of a large diameter natural gas pipeline from the North Slope of Alaska to the Canadian Border and Midwestern States. The Richardson Highway will be impacted by the projected increases in heavy truck traffic and the movement of pipe and oversized construction modules.

**Project Description/Justification:**

Work completed to date using federal funds: completion of 65% design, environmental document, gravel use agreement with US Army Corps of Engineers and other required permits. Work in progress: utility agreements, final plans, specifications and contract documents. Funding is for the construction phase.

This project will construct an overpass on the Richardson Highway over the Alaska Railroad tracks near Moose Creek (approximately MP 345 of the Richardson Highway). The project will maintain the divided highway and construct separated bridges over the Alaska Railroad. In addition, the project will construct a new approach to the Moose Creek access road and reconstruct an existing median opening near Moose Creek.
