Brief Summary and Statement of Need:

The harbor grant program continues to show strong local interest. Eleven applications requesting a total of \$21,084,645 in matching state funds were received for FY12. This represents a 22% increase in state funding requests as compared to last year. If fully funded by the Governor and the Legislature, the department can take credit in providing over \$42 million towards local "construction ready" harbor projects.
