**Principal's Priority**                      3

Initiate a Peer Meditation Program at Ptarmigan. This would require funding to train staff and students. It may also require purchase of a curriculum for the student training. To fully implement would require funding for 2 full days of training students. This would involve 3 days of release time for 4-6 teachers to train students. Request includes cost for funding substitutes to cover the teachers' usual duties. Matching donations from local businesses/churches for training space will be sought. Also includes lunch and snack for approximately 40 students. Funding for tees shirts, certificates, clipboards, chart paper, and laminating machine.

**Benefits if Project is Funded**

Ptarmigan staff has made a commitment to initiate this program. However, with funding we will be able to see the implementation of this program much sooner. We will be seeking matching funds and donations in anticipation of approval of this grant. We currently have staff interested in signing up for the adult training this year. With approval of funding we will be able to start the student training next fall on a larger scale than currently planned.
