Project Description

Principal's Priority 9

This request is to fund a pilot program of music in the classroom for six learning environments in a school that provides academic and behavioral direction for students with the designation of Emotional Disturbances and FASD characteristics. Research supports that music education can facilitate learning, especially the learning of students who have the behavior characteristics of FASD, excessive fidgeting being easily distracted, difficulty focusing and following instructions, daydreaming, difficulty with materials management, impulsively acting before thinking, ect. Numerous studies have been conducted throughout North America that substantiate the idea that music education can be an immeasurable tool to assist students with both cognitive and behavioral needs. Written guidelines will be established for all environments with data collection being a primary component of the study providing baseline and summary data to be presented to the Special Education Department at the conclusion of the school year.

Benefits if Project is Funded

The opportunity to implement a pilot therapeutic program for our students at Whaley allows us to find innovative ways to change behavior. With the success of this program, we could get more students out in neighborhood schools rather than attending a separate day school.
