
Dear Senator Olson:

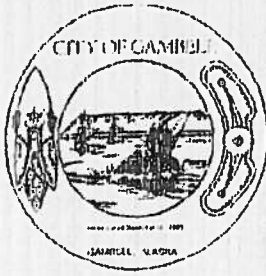

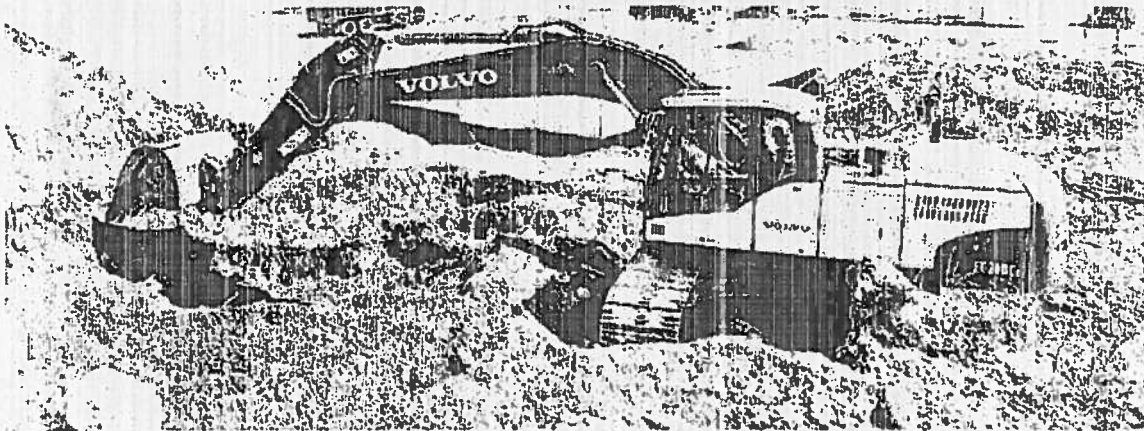
