

Dear Supporter of Education:

Having served as a Teacher, Principal, Assistant Superintendent and Superintendent with the Chugach School District (CSD) for 17 years, I have invested much of my livelihood into orchestrating the success of Alaskan youth through the Voyage to Excellence (VTE) program. While I have seen many succeed and shine, state statistics paint a less positive picture. The percentage of Alaska teens 16-19 neither in school nor graduated from high school has increased 25% from 2000 to 2008, ranking Alaska 47th in the nation for high drop-out rates. Minimal quality educational options exist for rural students, including opportunities that allow students to successfully transition into post-secondary school/training or the workforce. This results in increased dropout rates across Alaska.

Alaska's high dropout rate affects all Alaskans, not just in lost opportunities and an overall less employable workforce, but also monetarily. Nearly 4,000 students did not graduate from Alaska's high schools in 2009. The lost lifetime earning in Alaska for that class of dropouts alone, totals more than \$1 billion. Alaska would have saved more than \$57 million in health care costs over the course of the lifetimes of each class of dropouts had they earned their diplomas. Alaska's economy would see a combination of savings and revenue of approximately \$19 million in reduced crime spending and increased earnings each year if the male high school graduation rate increased by just five percent.

Many of these negative ramifications are preventable. The Chugach School district's Voyage to Excellence (VTE) program is a complimentary program to public school. Geared to individualize and to provide real-life academic experience, 98% of VTE students complete the requirements needed to receive a high school diploma. VTE has over 15 years of proven results and of those who completed VTE from 2003-2008: 39% are in college, 53% in work force (majority locally).

To continue to provide the immense benefits to students, CSD needs your help.
