Funding Details:

Last year, the Haines Borough School District received a Legislative Capital Appropriation of \$250,000 for the replacement of the Haines High School gymnasium floor.

## **Detailed Project Description and Justification:**

Last year, the Haines Borough School District received a Legislative Capital Appropriation of \$250,000 for the replacement of the Haines High School gymnasium floor. This was to replace a wood floor that was installed when the original building was constructed in the 1970s. It is worn out. The underlayment has exceeded its life span and hardened so that the floor has no cushioning. It presents a safety issue for students and community members who use the gym.

As we moved forward to plan the replacement of this floor, we were asked by the architect to send out a sample piece of the floor, along with the underlayment and glue, to test for asbestos. This test proved positive. This put a halt to our initial plans to replace the floor for the 2011/12 school year. When we finally received an estimate to have the current wood flooring removed and abated, it turned out to be \$135,520. This is over half of the \$250,000 appropriation we received for this project. Initially we had thought we could save money by removing the floor ourselves. We anticipated making a little money by selling sections of the floor to alumni and other community members. Finding asbestos was a serious setback for us.

We have exhausted all options to find cheaper methods of abatement. Without additional help, this project will be difficult to initiate and complete in time for use during the 2012/13 school year.

In further consideration of the gymnasium project there has been a lot of community interest in replacing the bleachers -which have also been in place since the school was constructed in the 70s. Besides being worn and difficult to pull open and
close, they are not ADA compliant or friendly for our senior citizens. There have been several falls recently as people have
made the large step from the top of the bottom bench to the floor. This is a safety hazard. We have received a quote of
approximately \$100,000 for replacement of those old bleachers with new ADA compliant ones that are similar to what has
been put into newly constructed school gymnasiums such as Metlakatla, Thunder Mountain High School in Juneau, and
many other rural schools throughout the state.
